FINANCE:

Mr. Verdonik was absent. Mr. DeGraw reported that the contractor is back onsite on Project 2 after a lull in the work. He noted the change order on the table to replace the suction lines to the pumps at Deepavaal and coat the wet well. The contractor is anticipating an October completion date.

INSURANCE & LEGISLATIVE REVIEW:

Mr. Runfeldt deferred to Mr. Jacobs who discussed a pending regulatory matter that originated with the Local Finance Board called the Employee Compensation Disclosure Process. He distributed sample forms and discussed the additional proposed requirements and costs this legislation would entail. He noted that AEA and other organizations are submitting their comments to the LFB with the hopes of changing or eliminating these requirements.

LEGAL & PUBLIC RELATIONS:

EXECUTIVE DIRECTOR'S REPORT:

1. NJPDES Discharge Permit – Request for Hearing

The hearing has been adjourned and a telephone conference between Diane Alexander and the DAG has been scheduled for 3 p.m. on August 10, 2017. A draft of the Settlement Agreement has been prepared by the DAG and is under review.

2. Interceptor Sewer Project

Six Certified letters recently went out to residents in Lincoln Park. Three of these requested contact information in order to access their properties to inspect manholes. The other three letters are follow-up letters to three previously notified residents. As of this morning, we have received two responses.

Mr. O'Brien referred to the copies of the monthly Engineers Report on the table and brought the members up-to-date on all on-going projects.

NEW BUSINESS: Preliminary FY 2018 TBSA Budget Review

Mr. Bongiovanni noted that the TBSA Budget has been revised to reflect a reduction in the Reserve for Capital Improvements to \$900,000 and a change in Pequannock's flow. He noted Page 17 of the budget (on the table) which includes both changes. This results in an increase in total Participant Charges of 0.05%. He reviewed the budget approval and adoption schedule. Mr. Bongiovanni noted that the flow estimates can be amended as needed.

<u>NEW BUSINESS:</u> FY 2018 DCA Budget with Capital Budget

Mr. Bongiovanni noted the 2018 DCA Budget and memo on the table. He stated that the Capital Budget was developed from the FY 2017 Consulting Engineer's Report which was

presented to the Board last month. The Capital Budget shows \$20,600,000 in projects over the next six years which will be funded by a combination of Renewal & Replacement, Construction Fund and Bond Financing. He requested that if any Board Member had any comments or changes, to please let him know prior to the next board meeting.
